JUSTICE HAVE SUPPLIED THE FOLLOWING REVISED INFORMATION CONCERNING BALLYBAY.

- 1) FOLLOWING THE HIGH COURT DECISION ON BAIL ROBINSON MADE A FURTHER APPEARANCE BEFORE BALLYBAY DISTRICT COURT. AT WHICH TIME THE JUSTICE CHANGED THE REMAND DATE TO 30 OCTOBER (THIS IS INSTEAD OF THE DATE SET AT THE INITIAL HEARING VIZ 7 OCTOBER)
- 2) NEW CHARGES OF 2 OCTOBER
  - A) 2 (TWO) RATHER THAN 1 (ONE) CHARGES OF ASSAULTING A PEACE OFFICER HAVE BEEN INTRODUCED, ONE IN RELATION TO GDA CARTY, ONE IN RELATION TO GDA OHARA.
  - B) THE NEW MALICIOUS DAMAGE CHARGES ARE AS FOLLOWS.
    - 3 CHARGES OF MALICIOUS DAMAGE TO MOTOR VEHICLES (VALUE 7812.15)
    - 1 CHARGE OF MALICIOUS DAMAGE TO 4 ROAD SIGNS (VALUE 136.31)
    - 1 CHARGE OF MALICIOUS DAMAGE TO A LOUDSPEAKER (163.56)

OFFENCE(S) CHARGED:-

That you Peter David Robinson together with other persons, not before the Court, on the 7th day of August 1986 at Gallagher, Clontibret, County Monaghan in the District Court Area of Ballybay and in District No. 6, with intent to carry out a common purpose, did assemble together in such a manner as to endanger the public peace.

Contrary to Common Law.

That you Peter David Robinson on the 7th day of August, 1986 at Gallagher, Clontibret, County Monaghan in the District Court Area of Ballybay and in District No. 6, did assault Garda Patrick Carty, Monaghan Garda Station, occasioning actual bodily harm to him,

Contrary to Section 47 of the Offences Against the Person Act, 1861.

That you Peter David Robinson on the 7th day of August, 1986 at Gallagher, Clontibret, County Monaghan in the District Court Area of Ballybay and in District No. 6, did assault Garda Leo O'Hara, Monaghan Garda Station occasioning actual bodily harm to him,

Contrary to Section 47 of the Offences Against the Person Act, 1861.

That you Peter David Robinson on the 7th day of August 1986 at Gallagher, Clontibret, County Monaghan in the District Court Area of Ballybay and in District No. 6 did unlawfully and maliciously commit damage to a motor car Registration Number ZG-2125, the property of the Minister for Finance, to the amount of IR£677.63p,

Contrary to Section 51 of the Malicious Damage Act 1861, as amended by Section 12 of the Criminal Justice Act, 1951.

The above charges were preferred at Ballybay District Court on 8 August 1986. It is understood that a number of further charges were preferred on 2 October (including a number of charges relating to incidents of malicious damage and assault charges under s.38 of the Offences against the Person Act 1861 in respect of each Garda
