(1) Army casualties

- (i) Private Malcolm Hatton, 1st Btn. Green Howards, shot by a sniper in Ardoyne on Sunday night, 8th August and died shortly afterwards.
- (ii) Bombardier Paul Challoner shot dead by a sniper in Derry on Tuesday night, 10th August.
- (iii) Private John Robinson, 1st Btn. Green Howards shot dead by a sniper in Ardoyne on Saturday, 14th August.
 - (iv) Private Winston Donnell of the UDR shot dead near Clady on the Tyrone-Donegal border on 9th August.

(2) Protestants shot dead

- (v) William Atwell of Bangor a security officer at Mackies engineering factory who was killed when hit by an exploding nailbomb on 9th August.
- (vi) Mrs Sarah Worthington of Ardoyne, shot by a sniper on 9th August.
- (vii) Mr. John Beattie of Shankill Road, found dead after shooting in the area. Gray low roud & was slot by New
- (viii) Mr. Normak Watson of Taylor Cottages, Armagh shot in a crossfire between troops and IRA men in Armagh on Tuesday night, 10th August.
 - (ix) William Ferris, 76 Glencairn Way died on 12th August as a result of bullet wounds received in a shooting incident on Tuesday night.
 - (x) William J. Strønge, 105 Conlig Street, shot on 11th August, apparently by accident (was following behind an army patrol when hit by sniper fire aimed at the soldiers).

(3) Other casualties

- (xi) Francis McGuinness of Andersonstown shot by the Army at Finaghy on Monday, 9th August (said to have been involved in rioting).
- (xii) Rev. Hugh Mullan shot while giving last rites to an injured man at New Barnsley on 9th August. Locals claim he was shot by the Army.
- (xiii) Noel Phillips of Ballymurphy shot by the Army at New Barnsley while trying to give assistance to Fr. Mullan.
 - (xiv) Leo McGuigan (aged 16) of Roseleigh Street shot by a sniper in the Ardoyne area on Monday.
 - (xv) Mrs Joan Connelly of Ballymurphy Road shot dead by British troops outside New Barnsley police station on Monday night.
 - (xvi) Daniel Teggart of New Barnsley shot in a gun battle in Ballymurphy on Monday night.
- (xvii) William McKavanagh of Henrietta Street. Body found after troops and IRA fought a battle in the Markets area of the city, but not clear if in fact he was an innocent bystander shot by accident or an IRA man.
- (xviii) Edward Doherty of Iveagh Street, shot dead on Monday in a gun battle in the Whiterock area.

- (xix) John McCruden shot dead by a sniper leaving Corpus Christi Church in Ballymurphy on 11th August.
- (xx) Desmond Healy, (14 years) shot by troops on 9th August in the Stewardstown area. Said to have been throwing petrol bombs.
- (xxi) Frank Quinn shot by the Army on 9th August.
- (xxii) Patrick McAdorey shot by British troops on 9th August. (IRA member, wanted by police and army for some time).
- (xxiii) Seamus Simpson shot by British soldiers on 11th August in Anderstown. Said to have been throwing a nail bomb. (IRA volunteer).
 - (xxiv) Hugh Herren, Drumleek Drive, Shantallow, shot dead by British troops in Derry on 13th August.
 - (xxv) John Laverty, Whitecliff Parade, Ballymurphy shot dead by British troops at Ballymurphy on lith August.
