UNLAWFUL ORGANISATION (SUPPRESSION) ORDER, 1983  
(An tOrdú um Chóghléasadh Nea-dhleathach) (Díchur), 1983).

Do rinne an Rialtas inniu Ordú mar a leanas:-

An tOrdú um Chóghléasadh Nea-dhleathach (Díchur), 1983.

DE BHRÍ go n-achtaítear le halt 18 den Acht um Chiontaí in Aghaidh an Stáit, 1939 (Uimh. 13 de 1939), gur cóghléasadh nea-dhleathach de réir bhri, agus chun críocha, an Achta sin cóghléasadh a dhéanann aon ní de nithe áirithe a áiritear san alt sin:

AGUS DE BHRÍ go n-achtaítear le halt 19(1) den Acht sin gur dleathach don Rialtas, mas dóigh, agus cibé uair is dóigh, leis an Rialtas gur cóghléasadh nea-dhleathach aon chóghléasadh áirithe, a dhearbhú le hordú gur cóghléasadh nea-dhleathach an cóghléasadh sin agus gur cheart, ar mhaithle le leas an phobail é a dhíchur:

AGUS DE BHRÍ gur dóigh leis an Rialtas gur cóghléasadh nea-dhleathach an cóghléasadh a bheireann Irish National Liberation Army (I.N.L.A. freisin) mar ainm air féin:

ANOIS, i bhfeidhmiú na cumhachta a thugtar dóibh le halt 19(1) den Acht um Chiontaí in Aghaidh an Stáit, 1939, ordaíonn an Rialtas leis seo mar a leanas:-

1. An tOrdú um Chóghléasadh Nea-dhleathach (Díchur), 1983, is teideal don Ordú seo.

The Government today made an Order as follows:-

Unlawful Organisation (Suppression) Order, 1983.

Whereas it is enacted by section 18 of the Offences against the State Act, 1939 (No. 13 of 1939), that an organisation which does any of certain things enumerated in that section shall be an unlawful organisation within the meaning and for the purposes of that Act:

AND WHEREAS it is enacted by section 19(1) of the said Act that, if and whenever the Government are of opinion that any particular organisation is an unlawful organisation, it shall be lawful for the Government by order to declare that such organisation is an unlawful organisation and ought, in the public interest, to be suppressed:

AND WHEREAS the Government are of opinion that the organisation styling itself the Irish National Liberation Army (also the I.N.L.A.) is an unlawful organisation:

NOW, the Government, in exercise of the power conferred on them by section 19(1) of the Offences against the State Act, 1939, hereby order as follows:-

1. This Order may be cited as the Unlawful Organisation (Suppression) Order, 1983.

2. Dearbháitear leis seo gur cónaítear nea-dhleathach an cónaítear a bheireann Irish National Liberation Army (I.N.L.A.) freisin) mar ainnm air fein agus gur cheart, ar mhaith le leas an phobail, é a dhíchur.

2. It is hereby declared that the organisation styling itself the Irish National Liberation Army (also the I.N.L.A.) is an unlawful organisation and ought, in the public interest, to be suppressed.
