STATEMENT FOLLOWING GARVAGHY ROAD PARADE

STATEMENT BY SECRETARY OF STATE, SIR PATRICK MAYHEW QC MP

The following statement was issued today by the Secretary of State, Sir Patrick Mayhew QC, MP:

"I entirely support the further operational decision which the Chief Constable has made, which I know was informed by a wide range of contacts and discussions, including the valuable contribution made by the four Church leaders.

It is self-evidently right for police decisions to take account of changing and developing circumstances.

The violence which has disfigured the Province has to stop.

The events of the last few days have exposed how divisive the issue of marches and street parades can be in our society. There is no simple and easy way to resolve this problem. But neither can there be any question of ignoring it. The Government agrees with the Church leaders that the long-term solution and the immediate problems cannot be separated, and for its part will be considering urgently over the next few days what steps need to be taken to avoid in future years the conflict and the dangers we have witnessed this month."

Victory for Mob Rule?

Today's operational decision is not a victory for mob rule any more than last Saturday's decision was, as alleged, a victory for the IRA. The decision in both cases reflected the judgement of the Chief Constable as to what he, and the RUC, must do, on the balance of circumstances and risks, to uphold public order and protect life. As the Chief Constable said last Saturday, the question was finely balanced. The balance has clearly shifted, and the Chief Constable accordingly decided that the authorisation of a limited parade was best designed to protect life. As last Saturday, we stand fully behind the Chief Constable's decision.

McKenna lured to bogus meeting?

I understand that Archbishop Eames has said that he spoke to Mr McKenna and others this morning, and that as far as he knew there was no question of Mr McKenna being held incommunicado.
