Dear First Minister and Deputy First Minister

We confess to concern that the establishment of the governance structures envisaged in the Good Friday Agreement – the Executive, the Civic Forum, the North/South Ministerial Council, and the East-West Council – is not yet assured.

We are only too conscious of the difficulty of the issues with which the political process has been wrestling. The purpose of this letter is to offer our full support for the intensification of effort which has been under way to achieve a speedy resolution.

Until the structures are up and running, the Agreement cannot begin to deliver the 'bread and butter' results for the economy and society to which so many look forward. Indeed there is a risk of a damaging vacuum, with resultant uncertainty as regards sense of direction and with decisions which should be urgently taken being delayed.

Northern Ireland's ability to capitalise in economic terms on the Agreement depends on a perception in the wider world that we have achieved political stability, thereby giving us a level playing field in the competition for inward investment. We feel that, until people see the arrangements for Government in place, there will be a degree of scepticism as to whether a corner has really been turned.

Notwithstanding whatever political progress is made, there remains of course the Drumcree situation, which has the ability to continue to mar Northern Ireland's image, with negative consequences for the economy and particularly for our tourism prospects. That was amply demonstrated again by the further headline – grabbing incident at Drumcree last night, which augurs badly for Portadown in the remainder of 1998 and beyond.

We wish you all success as you seek to move forward on the political front. If there is any way in which you think we might be able to reinforce or supplement your efforts, we shall be delighted to do so. If you feel that it would be useful to meet, we are at your disposal. Indeed, were the impasse set to continue, we would be keen that a meeting should take place at an early date.
