FLYING OF THE UNION FLAG ON GOVERNMENT BUILDINGS

- 1. Your minute of 17 December raised the question of the flying of the Union flag on Government buildings over the Christmas holidays, and specifically asked that I direct that no flags be flown over the Christmas period and until the Executive could properly address the issue.
- 2. Neither I nor the First Minister have the power to do as you request. Until devolution the flying of the Union flag was done on specified days by direction of the Secretary of State. As you acknowledge, the Executive Committee has yet to consider the matter and, therefore, any direction to vary the arrangements current at devolution would have to come from individual Ministers.
- 3. The matter will be raised with the Executive Committee early in the New Year.

FLYING OF THE UNION FLAG 1999

I enclose a list of the days in 1999 on which flags shall be flown on Government Buildings.

I would take this opportunity to remind you that the Union flag should fly on all Government Buildings on Europe Day ie 9 May. Buildings with one flagpole should fly the **Union** flag but those buildings with two flagpoles should arrange to fly the Union flag **and** the European flag. On the buildings with two flagpoles, please ensure that the Union flag is given precedence ie the Union flag should fly on the left flagpole and the European flag on the right as you face the building. If you have any queries regarding this instruction please contact me.

No further notification will be issued other than in respect of special, unlisted occasions when flags will be flown at either full or half-mast, by direction of Her Majesty The Queen.

Please ensure that where it is possible to do so that the Union flag is flown from <u>all</u> Government Buildings on the prescribed dates.
