



Dear David

I wrote to you before Christmas to advise that I had received the Chief Constable's report on his policing response to the problems in Glenbryn/Alliance/Ardoyne.

Whilst our offices were in the process of arranging a meeting to allow us to discuss this, the events of last week required that I had to move rather more quickly. Although the violent public disorder of last week has stopped, the situation in that area remains potentially very serious. Therefore I am anxious to respond positively and quickly to the Chief Constable's recommendations.

In November last year you wrote to all those interested parties, on both sides, setting out a package of initiatives that would address the concerns of both communities. The police agreed to provide community policing and additional mobile patrolling and static points. This has been done. The Chief Constable, in his report, considers what additional security measures would be appropriate. Although he does not recommend a gate at the Alliance/Ardoyne junction he does recommend a CCTV system for that area as a permanent solution. Accepting that this will take some time to design and install he recommends a temporary solution. X of a 360 degree camera to be located at the interface.

The Chief Constable has considered all feasible options for the location of the camera taking into account camera coverage and protection of the equipment. He has concluded that the quickest solution is to site the camera within the Everton Complex car park, though the entrance to the rear of the car park would also be suitable. However, the Chief Constable advises another suitable atternative and that is to use the existing street light directly outside the complex at the junction of Alliance Avenue/Ardoyne Road. This would only be feasible if the light standard can take the additional weight of a bracket and camera and can supply suitable

power. Additionally, in order to protect the equipment from physical attack and vandalism, the standard may need to be reinforced. This could raise issues of road safety. The police would need to explore this with both engineers within the Department for Regional Development and the NIB.

These options would require the support of Devolved Ministers to allow the police to use Devolved Administration property. If agreement is not given then I will need to reconsider the position at that point. Clearly in designing a permanent system for community safety the Chief Constable will be consulting widely and engaging the Policing Board.

I would hope that you could see your way to facilitating the installation of this temporary system, which would provide the police with an additional and essential tool to address the problems suffered by both communities at that interface. Given the urgency of the situation, I would be anateful for an early reply.

I am writing in similar terms to to Mark Durkan.
