'A SHARED FUTURE' - LETTER FROM SINN FEIN

Summary

Issue: Bairbre de Brun has written to you, criticising

'A Shared Future'.

Timescale: Routine.

Presentational issues: None at present.

Recommendation: To invite representatives of Sinn Fein to a

meeting to discuss the way forward on good

relations policy.

Background

1. Bairbre de Brun wrote to you on 26 June about the consultation document on good relations, 'A Shared Future'. The letter is critical of the document, and is clearly intended to 'mark your card' in advance of a more substantive response later in the summer.

- 2. The main points of Sinn Fein's analysis appear to be:
 - the Government has ignored the structural causes of poor community relations, which Sinn Fein see as the main issue;
 - structural inequality is the principal cause of, as well as a manifestation of, poor community relations; and
 - the promotion of equality is the key to improving community relations.
- 3. Sinn Fein is clearly seeking to position or align the issue of community relations within its equality and human rights agenda.

This is a typical response – almost any issue of social policy that arises is appraised in terms of the contribution that it might make to this agenda and treated accordingly. Equally, any social policy that is not presented by Government as stemming directly from equality and human rights commitments is presented as a weakening of those commitments.

- 4. This general Sinn Fein position has resulted in a simplistic analysis of community relations, which is flawed in its description of the causes and necessary policy response. There is of course, no doubt that a lack of equality has been a contributing factor to poor community relations. However, Sinn Fein ignores the many other factors, not least the violent conflict that resulted in over 3000 deaths. Sinn Fein also portrays poor community relations (for nationalists) as being a purely rational response to the political situation. This ignores the more visceral component of sectarianism, which is all too prevalent in both communities.
- 5. In terms of a policy response, it is clearly accepted that progress in promoting equality of opportunity can contribute to improving good relations. However, to suggest, as Sinn Fein does, that the promotion of equality should be the key component of good relations policy is to ignore the key message in A Shared Future, that indirect approaches alone are insufficient to deal with sectarianism and the abnormal relationship between sections of the Northern Ireland Community.

Recommendation

6. A key aim of A Shared Future is to promote debate on the way forward. I recommend a brief reply to Ms de Brun, inviting representatives of Sinn Fein to a meeting to discuss the issues.

Des Browne had planned similar meetings with Assembly parties, and you may wish to reinstate these.
