Lawyers for campaigning dad Raymond McCord have issued a writ against Chief Constable Sir Hugh Orde - the first step in taking the PSNI to court over agent Mark Haddock and the 1997 murder of Mr McCord's son. Mr McCord says the legal action is the "next step" in his long campaign to expose his son's killers, following January's report by Police Ombudsman Nuala O'Loan. And he believes it will answer critics who claim there is a lack of evidence to support the report's findings of collusion in at least 10 murders. "My legal team says the Chief Constable has a major case to answer in court," Mr McCord. "I hope a lot of other families caught up in this do the same." Mr McCord is claiming damages for negligence and malfeasance in public office by police officers. The writ is issued to Sir Hugh as the representative of the force.
