	Said a PSNI spokesman: "We don't know anything about this, but we need the public's help in bringing these people before the courts.	
	"We as yet have not been able to identify the gunman. One woman was charged with and convicted of assisting offenders and is currently serving a jail sentence, but nine years on Mr Lamph's family still grieves and his killer is still free.	
	"Public assistance is vital to this investigation. We would like witnesses to come forward.	
	"Any cyclists who lived in the area or used that area at the time of Adrian Lamph's killing are being asked to contact police. Anyone who may have lost or had a bicycle stolen and not yet reported it to police should also make contact."	
	Terror granny Muriel Gibson was jailed for eight years for a string of offences including impeding the arrest and prosecution of the killers of Adrian Lamph, membership of the LVF, possessing firearms, detonators and pipe-bombs.
