Carolyn and Donna will be travelling with people from Northern Ireland who have been affected by the troubles, giving them a chance to travel overseas, to work on-site building the houses and to spend time with local people who have also suffered terrible hardship.

The Fund approached several victim support groups for nominations and the team will be getting together soon to talk about the trip and the hard work involved!

GROUPS' CORE FUNDING

Last month groups and organisations that applied for grants from the new round of Core Funding (2003-2005) received news of the decisions of the Committee in their case.

Sixty-three applications were received to the Scheme. When these were counted up they totalled more than £9 million against a fund of £3 million. We had planned to set aside roughly 10% of the £3 million to cover contingencies arising during the currency of the scheme – for example to fund successful reviews or to be able to make Core Funding grants to any new groups that emerge. In the event, we managed to identify an equivalent amount from within VLU and VU budgets and with the Minister's approval this will be <u>added</u> to the £3 million to make up a Core Funding contingency reserve.

This means we have been able to allocate all of the £3 million straight away. But with the best will in the world, it was clear that much trimming of bids would have to be done. In the final analysis, 15 of the 63 applicants for one reason or another will not receive Core Funding. They may of course qualify for other help, for example from the Victims and Survivors Development Grant Scheme, which is also funded by the VLU and administered by the Community Relations Council.

The awards were decided by a Committee appointed by the Intermediary Funding Body – the Community Relations Council. And in allocating money from the Scheme priority was given to groups and organisations that provide unique benefits to victims of the Troubles. The procedures adopted by the Committee are open to scrutiny and anyone who feels they have grounds to do so may ask for a review of the decision – see paragraph 12 of the Guidance Notes for the Scheme.

While the Victims' Minister continues to press for more money for Victims' initiatives, we have no option at present but to work with what we have. One piece of good news is that all those that applied whose main business is working with victims will receive help either through the Core Funding Scheme or the Victims and Survivors Development Grant Scheme.

This may be a good time to remind those who are drawing Core Funding of some of the Key Best Practice Recommendations that came out of the recent Audit Report. In short, the auditors are saying responsibilities for groups' financial and operational management should be shared across the Management Committee. The Committee needs to be presented with financial and management information on a regular basis, they need to sign that they have seen it and that record needs to be kept. Groups who have not yet drawn up a Financial Procedures Manual need to think now about doing so and, of course, a separate bank account needs to be opened and maintained for all Core Funding (2003–2005) receipts and payments.

Copies of the Auditors' Recommendations were distributed to groups some time ago. They form a very useful guide for groups seeking now to draw up a Financial Procedures Manual. IMPORTANT REMINDER The first round of Core Funding will soon be completed. To help with the transition to the new round, all Income and Expenditure claims must be submitted as soon as possible to C.F.N.I.

HUGE RESPONSE TO WESTPORT TRIP

TRAUMA ADVISORY PANEL CO-ORDINATORS

What are Trauma Advisory Panels?

Trauma Advisory Panels (TAPs) were set up in each Health Board area in 1999 to take forward work and develop partnerships in a range of areas relating to victims. Initially only the Western Board appointed a full-time worker, funded by the local District Partnership and Foyle Health Trust, to co-ordinate the activities for that Panel. However, it emerged from the responses to both research carried out by the OFMDFM Victims Unit in 2001 and the Victims Unit's consultation paper on a victims' strategy that the work of the TAPs would be an important consideration in the planning and development of services to meet victims' needs. The Victims Unit therefore offered to fund a full-time co-ordinator in each TAP until 2004 to develop its potential and work effectively with victims in its area.

Who Co-Ordinates the Panels?



Sharon Campbell - EHSSB Sharon has been making contact with individuals within the statutory and voluntary sectors and self help groups within her Board area.



Sheena Funston - WHSSB Sheena has been heavily involved in training for self-help groups and looking at ways to maintain sustainability.



Clare Quigley - Southern Board Clare has been building contacts with Community Development Teams within Trusts and District Councils.



Sheelagh Sheerin - Northern Board Sheelagh has been working on a policy on displaced families and has mainstreamed awareness training on victims' needs into social worker training in the Northern Board area.

What are their roles?

To analyse need and develop networks and services including compiling directories of the services available.

They all meet regularly with the Victims Unit to share best practice and feed back information on local need to the Unit.

All of the Co-ordinators feel that it is important to reach out to individuals as well as self-help groups and are doing this through contact with churches, trauma counsellors, Community Development Teams, GPs, Councils and the Northern Ireland Housing Executive and by running complementary therapy events.
