# £500,000 For Victims In GB

Victims initiatives in Great Britain are to receive funding of £500,000 over the next three years. The new Victims Minister, Des Browne, made the announcement on a visit to the Warrington Peace Centre in July.

From this funding £250,000 has been allocated to the Legacy Project, which is an initiative of the Tim Parry Johnathan Ball Trust, based at the Warrington Peace Centre. The Legacy Project will aim to identify and meet the needs of victims of the Troubles living in Great Britain, co-operate and collaborate with other groups and organisations working in victim support, develop a resource base for victims throughout the UK and Ireland, and, will also forge new links between Great Britain and Northern Ireland with those who provide support to victims in both the voluntary and statutory sectors. Consideration is being given to other areas where the remaining £250,000 can be best put to use.

Do you have views on the Core Funding Scheme for Victims/Survivors Programme? If so, CLIO Evaluation Consortium would like to hear from you! The group is carrying out the independent evaluation of the Northern Ireland Voluntary Trust (NIVT) administered scheme and have written the following letter. Copies of the leaflets mentioned in their letter are enclosed.

#### Dear Friend

As the research group responsible for producing an evaluation of the NIVT administered Core Funding for Victims/Survivors Programme, we are contacting you to introduce ourselves and invite your participation in the evaluation of this scheme.

You will find enclosed a leaflet explaining who we are, and outlining the objectives, principles and process of the evaluation. As you will see from the leaflet, there are two main strands to the evaluation; firstly, assessing the effectiveness of the projects funded and the extent to which they have contributed to the Core Funding programme's overall goals, and secondly measuring the effectiveness of the NIVT's management of the Core Funding programme.

We have already been in contact with groups that have been funded through this programme, but are hoping to also hear from victims/survivors groups or individual victims/survivors who have not been impacted by this funding programme. We are particularly interested in hearing from victims/survivors groups who did not apply for a grant as to the reasons for this. For your information we have also enclosed a copy of the original leaflet that spells out the objectives and application criteria of the funding programme.

### **Coroner Services Under Review**

Arrangements for death certification, inquests, post mortem examinations, and the full range of services provided by Coroners including treasure trove are under review in England, Wales and Northern Ireland.

The review is expected to take 18 months and the group carrying out the review would welcome the views of individuals or groups who have experience of the Coroners Office services. If you would like to submit your views, contact

#### The terms of reference for the Review are as follows:

- To consider the most effective arrangements for identifying the deceased and for ascertaining and certifying the medical cause of death for public health and public record purposes, having regard to proposals for a system of medical examiners.
- To consider the extent to which the public interest may require deaths to be subject to further independent investigation, having regard to existing criminal and other statutory and non-statutory investigative procedures.
- To consider the qualifications and experience required, and the necessary supporting organisations and structures, for those appointed to undertake the duties for ascertaining, certifying and investigating death.
- To consider arrangements for the provision of post mortem services for the investigation of deaths.
- To consider the consequences of any changes arising from the above for the registration service and the role of the coroners under the Treasure Trove Act 1996, and to consider where Departmental responsibilities for the arrangements should be located, having regard both to coherence for bereavement services and effective accountability.

Billy's replacement from the 5th of November is Sarah Todd. Sarah tells us she is delighted to be in post and looks forward to meeting with many of the groups over the coming months.

### The Northern Ireland Memorial Fund Peace – Reconciliation – Support

### What is the Northern Ireland Memorial Fund?

The Northern Ireland Memorial Fund is an independent charity that was established following the publication of Sir Kenneth Bloomfield's report "We Will Remember Them". The Fund's aim is to promote peace and reconciliation by providing practical support and recognition to individuals and families who have suffered as a result of the 'Troubles' in Northern Ireland.

#### What help is available from the Fund?

The Fund has to date introduced six schemes :

1. The Education and Training Scheme is the Fund's most recent scheme and was launched during the Summer. It is designed for children and adults whose education or career has been affected by the Troubles and who now want to improve their prospects through education or training. The scheme is open to individuals who as a result of the Troubles have either:

- lost a grandparent, parent, partner, child, brother or sister;
- have themselves been injured;
- have become the primary carer for an immediate family member who has been injured.

2. The Chronic Pain Management Scheme provides grant assistance to enable individuals who have suffered physical injuries resulting in persistent chronic physical pain to access private consultations and treatment with a specialist in chronic pain management.

3. The Respite Break Care Scheme is for individuals for whom it has not been possible to take a break away from home and who as a result of the 'Troubles' have either:

- lost a child;
- lost a partner;
- have themselves been physically injured in an incident;
- have become the Primary Carer for an immediate family member who has been physically injured.
- 4. The Amputee Assessment Scheme is designed to give amputees the opportunity to be assessed to determine if they might positively benefit from an alternative prosthesis to the one that they are currently using.

**5. The Wheelchair Assessment Scheme** is designed to give wheelchair users the opportunity to be assessed to determine if they might positively benefit from an alternative wheelchair to the one that they are currently using.

6. The Small Grants Scheme provides individuals, who are currently experiencing financial difficulties, with small grants up to £500 to assist with the purchase of essential household items and services, if you have either:

- lost a parent, partner or child;
- have yourself been injured;
- are the primary carer for an immediate family member who has been injured;
- lost a brother or sister and were financially dependent on them at the time of the incident, or if they were with their brother or sister at the time of the incident.
