### model of service delivery to victims

The evaluation of services to victims and survivors of the troubles, carried out in 2001 by Deloitte and Touche on behalf of the Victims Unit of the Office of the First Minister and Deputy First Minister, recommended that the Unit should develop a service delivery model showing the roles of Government and other structures involved with victims' issues. This was borne out during the consultation on the draft victims' strategy when victims told us that they wanted more information on the services provided.

The Victims Unit, in co-operation with the Victims Liaison Unit of the Northern Ireland Office and the Northern Ireland Memorial Fund, has produced the model opposite which outlines the role of providers and the type of services provided.

Local partnerships and Trauma Advisory Panels are made up of a combination of statutory and non-statutory representatives. Parallel Service Providers are groups or organisations which provide professional services that are close, or parallel, to services that are provided by the statutory sector.

#### RESPONSIBILITIES

- Ensuring that the needs of victims are addressed in the devolved administration, including the management of an interdepartmental working group on victims' issues and management of a £3m Strategy Implementation Fund.
- Ensuring the implementation of the actions contained in the victims' strategy, 'Reshape, Rebuild, Achieve'.
- Management of the Victims Measure of Peace II.
- Funding a support worker in each Trauma Advisory Panel to develop networks between service providers and victims, and their representatives at local level.
- Maintenance of a website with information of interest to victims and their representatives.
- Operating a Helpdesk for people experiencing problems in dealing with any of the devolved government departments or other public bodies.
- Support for Ministers in the devolved administration.

#### RESPONSIBILITIES

- Provision of core funding to victims' groups.
- Management and provision of grant aid to the Northern Ireland Memorial Fund.
- Ensuring that victims' issues are dealt with in the reserved and excepted fields in Northern Ireland, particularly in areas such as compensation, criminal justice, security and dealing with the 'disappeared'.
- Prioritisation and allocation of central government funding for victims.
- Primary responsibility for implementing the findings of the Bloomfield report.
- Support for Ministers in the NIO, particularly the victims' Minister.

### Both Organisations have responsibility for:

- Improving the capacity and professionalism of victims' organisations and introducing core values and standards for groups to adhere to.
- Organising seminars and events on topics of interest to victims and victims' organisations.
- Providing information to ensure that victims known which part of Government to access for information and help.
